## INTRODUCTION

It costs approximately \$180,000 to run our Football Club each year plus thousands of hours of work provided free of charge by many volunteers. Paying registration fees on time is a small way for players to show their respect to the Club, their team mates and to those volunteers whose efforts allow our players to play football each week.

## PURPOSE OF THIS POLICY

The purpose of this Player Registration Fee Payment Policy is to provide guidelines for the payment of Flagstaff Hill Football Club player registration fees. It also provides guidelines for players experiencing hardship.

## WHO THIS POLICY APPLIES TO

This policy applies to players at the Flagstaff Hill Football Club.

## REGISTRATION FEES

All fees are shown on the previous page.

## PAYMENT DUE DATE

Due dates for all fees, are shown on the previous page. Players who have not paid fees by that date will be ineligible to play unless a payment plan has been previously agreed to with the Flagstaff Hill Football Club President, Chairman or Club Treasurer.

## OUTSTANDING DEBT

Existing players who possess a debt with the Flagstaff Hill Football Club will not be allowed to register for a new season until the debt is paid in full. A Grade players who possess a debt with the Flagstaff Hill Football Club will not receive any payments after a match win (instead, the applicable amounts will be deducted from their outstanding debt).

## FINANCIAL ASSISTANCE

Financial assistance requests will be handled confidentially on a case-by-case basis by the Flagstaff Hill Football Club President, Chairman and Treasurer. Players, parents, coaches, support staff and officials are encouraged to present cases in person to any member of the group who will have the final decision on any hardship case.

## PAYMENT PLANS

If a player is deemed to be eligible to enter into a payment plan, the payment plan will be negotiated with the Treasurer with the full amount due by no later than 30th June of the current season.

## ORGANISATIONAL RESPONSIBILITIES

The Flagstaff Hill Football Club will:

- ... Publish, distribute and promote this policy.
- ... Not allow any player to play regardless of personal ability or the ability to field a full side, if registration fees have not been paid by the due date, or a payment plan negotiated.
- ... Monitor and review this policy annually.

## INDIVIDUAL RESPONSIBILITIES

Individuals bound by this policy are responsible for:
